#### [2] SCHEDULE

Ten Races are scheduled for the Championship. Four races must be completed to constitute a Championship. When four or more races have been completed, a boat may discard her worst result. When 8 or more races have been held, a boat receives a 2nd discard.

#### Programme:

Monday, July 23 rd Registration

Tuesday, July 24th Registration till 11h 3 races- First warning signal at 13:30 Welcome cocktail Wednesday, July 25 th 3 races- First warning signal at 13h30

Thursday, July 26 th 2 races- First warning signal at 13:30; dinner at 19h

Friday, JULY 27 th 2 races- First warning signal at 11:30; Prize giving, around 16h

#### [3] RULES

The regatta will be governed by the rules, as defined by the Racing Rules of Sailing (RRS),

The individual Class Association Rules will apply.

The applying Prescriptions of the Federation Française de Voile will be included in the sailing instructions. In case of conflict between French and English in the notice of race, the sailing instructions or any official amendments, the English text shall prevail.

#### [4] ELIGIBILITY

ISAF eligibility, as defined by Regulation 19 - Eligibility Code, is required for all competitors.

All competitors shall be current members of the appropriate class association, and their membership card shall be produced or their membership otherwise verified.

#### [5] ENTRIES

Entries shall be made on the official entry form, on website with payment at SRR.

**All entries and entry fee deposits** shall be received by the Organising Authority no later than 15 TH July 2007 or late charges will apply. French competitors will have to present FFV licence and advertising card (if necessary) –

The Entry Fees are, including back from water buffet -

- 1.- Entry and Payment Until 15 TH July 2006: Double handed boat €140.00 Single Handed 100 €
- 2.- Entry and Payment After 15 TH July 2006 Double handed boat €170.00 Single Handed 130 €

Integral Payment for booking shall be made in Euros, on website free of charges, by bank card to SRR. Final Payment will be done at the registration in La Rochelle .

Entries received within 14 days of the beginning of the Championship may be accepted only at the discretion of the Class association and the SRR, whose decision shall be final.





#### [6] SAILING INSTRUCTIONS

The Sailing Instructions will be available on each association website and will be issued to each competitor on completion of registration.

#### [7] SCORING

The RRS Appendix A- Low Point Scoring system shall be used. Each Association with a minimum of 8 boats will get a separate result.

#### [8] DECISIONS OF THE JURY

The decisions of the Jury shall be final in accordance with RRS 70.4.

#### [9] LIABILITY

Competitors will sail at their own risk in the Eurocup 2007 in La Rochelle. See rule 4 (RRS): Decision to Race. The Organising Authority, the SRR, the Class Associations and all parties involved in the regatta organisation do no accept any liability for any loss, damage or injury which may occur to person or property, both ashore and afloat, as a consequence of participation in the Championship. Each entry shall have a current Public Liability and Third Party Property Insurance policy, covering boat, helm and crew, including coverage when racing at the venue of the Championship, of not less than 1.5 million Euros (or the equivalent). The original Insurance certificate must be presented or local insurance can be bought for 6 €/person.

#### [10] PHOTOGRAPHS AND TV RIGHTS

By participating in the Eurocup, a competitor automatically grants to the Organising Authority, the Class Association, Management Group and the Sponsor the right in perpetuity to make use of and show, at their discretion, any motion pictures, still photographs, live or taped film or video on television and/or other media, showing him/her during the period of the competition, as well as to use such contents in any media whatsoever, for either editorial or advertising purposes or to be used in press information without compensation.
